

# Gordy Bubolz Wakeboard Camp & Water Ski School

## SCHOOL RULES WAIVER

PLEASE READ CAREFULLY AND TAKE ALL THE TIME YOU NEED TO READ THIS WAIVER.

Wakeboarding and Water Ski training require certain risks that the Gordy Bubolz Wakeboard Camp & Water Ski School (GBWC) will not prevent and cannot be held liable. Parents and students are to take every reasonable precaution to prevent their own injury (both physical & property) and injury to others (both physical & property).<sup>1</sup> All rules set by owners or staff must be strictly followed for student safety. The following are common events that require a risk that both parent and students should be aware of and will be liable for if they choose to participate. These risks are included, but do not limit, parent & student's responsibility to act reasonably to care for themselves and all other staff and students.

### Wakeboarding or Water Skiing Risks

Life Jackets are required at all times while in and around the water.

1. While Wakeboarding or Water Skiing:
  - a. A natural part of the sport is falling into the water. Parent & student will be held liable if a wakeboard, skis, ropes, any broken equipment, etc. strike the student at any point while in the water. Parent & student will also be held liable for any floating obstacle such as a buoy, any property of another, or natural obstacle student may strike. Parent and student will be held liable if the student is injured by a fall into the water.
  - b. Only a student can determine when he/she is ready to attempt a trick. If a student chooses to attempt a trick he/she is responsible for any injury despite any instruction given by a member of GBWC or other students.
2. While in the boat:
  - a. Student must obey the rules of the boat driver.
  - b. Student must keep his or her entire body within the boat.
  - c. Student must stay away from the ski rope.

### Training & Recreational Risks

If parent & student refuse to take responsibility for any training activity, parent or student MUST inform Gordy Bubolz of this decision and the student will not be allowed to participate in this particular training or recreational activity. If parent & student choose to participate, parent and student will be liable for injuries sustained.

1. Trampoline Jumping
  - a. Only one student may jump on the trampoline at a time.
  - b. No student may jump on the trampoline without supervision.
  - c. Each student must not attempt any trick that may put himself at risk of losing control and falling off the trampoline or hitting a harder part of the trampoline.
2. Swimming and Diving
  - a. Life jackets will be provided for all students. If a student refuses to wear a life jacket, they do so at their own risk.
  - b. Students must act with all reasonable caution when jumping and must not run before jumping off any platform.

<sup>1</sup> A student is any participant of a training exercise or entertainment within the scope of the activities of the camp and ski school.

Field Game Risks

- 1.Students will abide by all rules set forth within the parameters of any field game played while at GBWC.
- 2.Students will be mindful of hazards both natural and manmade on the property and will stay at least ten yards from the water and all fences on property.
- 3.Students may not leave the property in any game.

Driving While Within the Camp Week

Any and all students that choose to drive their own vehicles within their time at GBWC do so at their own risk. Any student that allows another into their vehicle and drives the individual takes FULL responsibility for the safety of all within their vehicle. Do so with CAUTION and parents please instruct Gordy Bubolz if a student is not allowed to take this responsibility.

Promotional Consent

Often students will be featured in promotional material for GBWC. If a student or parent does not want their child in any promotional material, they have the responsibility to inform GBWC.

Right to Dismiss for Inappropriate Behavior

GBWC reserves the right to dismiss from the school at any point in time any student whose actions are deemed irresponsible, malicious, or hazardous to the general safety of the school. In which case, there will be no refunds.

Medical Consent

I authorize Gordon A.A., Rhonda, Roy Yach, or Linda Yach, to consent to any diagnosis or treatment, and hospital care, to be rendered to the minor under the general or special supervision and on the advice of any physician or surgeon licensed to practice in the state of Wisconsin, when the need for such treatment is immediate, and when efforts to contact me are unsuccessful.
